29 April 2015 Day 02 Los Angeles Meal: B/D



30 April 2015 Day 03 Los Angeles Meal: B

Today we will drive to and tour Mt Palomar Observatory, south east of Los Angeles, to visit the historic 200" Hale Telescope and 60" Samuel Oschin Telescopes. Return to Los Angeles to tour Griffith Observatory and its Samuel Oschin Planetarium in the evening.



O1 May 2015 Day 04 Los Angeles – Phoenix - Flagstaff Meal: B

Take morning flight from Los Angeles to Phoenix. Upon arrival Phoenix Airport, met and drive to Flagstaff, afternoon visit to Lowell Observatory at Mars Hill. At Lowell Observatory we will visit the 24" Clark Refracting Telescope and 13" Pluto Discovery Telescope (used by Clyde Tombaugh in 1930 to discover the dwarf planet Pluto).





03 May 2015 Day 06 Flagstaff - Phoenix - Houston Meal: B

Transfer from Flagstaff to Phoenix Airport for your flight to Houston. Upon arrival Houston, met and transferred to hotel.

04 May 2015 Day 07 Houston

Meal: B

Full day visit Johnson Space Center at your own pace (transfer & admission fee included).



05 May 2015 Day 08 Houston Meal: B/D

Full day visit Johnson Space Center at your own pace (transfer & admission fee included).

06 May 2015 Day 09 Houston - Orlando Meal: B

Take morning flight from Houston to Orlando. Afternoon visit to Kennedy Space Center and take KSC Guided Tour, potentially an in-depth view of Kennedy Space Center or Cape Canaveral Air Force Station on a guided, special interest tour. This is led by a trained space expert. The Discover KSC: Today & Tomorrow tour includes up-close views of the space shuttle launch pads.





07 May 2015 Day 10

Transfer to Kennedy Space Center and you will have a full day free time there. Examples are Exploration Space (Explorers Wanted); 3D IMAX Films; Shuttle Launch Experience; Rocket Garden; Astronaut Encounter; US Astronaut Hall of Fame. Discover the 50-year history of the Cape and visit the historic rocket launch pads on the Cape Canaveral: Then & Now Tour.

08 May 2015 Day 11 Orlando – Washington DC Meal: B

Take morning flight from Orlando to Washington DC. TERMS & CONDITIONS

(Charter Group - SASI USA 2015)

1. Booking / Acceptance

Please read these Terms & Conditions carefully. By making a reservation with us, you have agreed to accept the Terms & Conditions herein, CBT Holidays accepts a booking with the understanding that full payment has been collected and held by CBT Holidays. Some of the group tours require a minimum number for guaranteed departure. CBT Holidays reserve the right to cancel the tour due to insufficient number at least 120 days before its departure date. On confirmation of your booking, CBT Holidays will reserve your place on your selected tours. It is your responsibility as the customer to check the accuracy of your booking and travel dates on receipt of you travel documents. The numbers of day duration in the itineraries include the day of departure and the day of return to Australia.

2. Deposit and final payment

All clients are required to complete the booking form and have them sent to your travel agent or CBT Holidays to start the reservation. To confirm the reservation, you will be asked to send us a nonrefundable deposit for each tour of \$500 per person within 15 days from the date of the confirmation of your booking to secure the reservation. The full amount of deposit will be refunded if we cancel the tour due to insufficient numbers. We must receive the balance of the tour payment no later than 180 days before departure which is on 28 Jan 2015. If we do not receive the tour deposit or final payment by the due dates, we reserve the right to cancel the reservation. In the case of billing errors, we reserve the right to re-invoice with correct pricing. For group tours, a late booking (within 60 days prior to departure) fee of \$120 may apply. All group air tickets are with strict conditions of non-refundable, non-transferable and non-changeable.

A second deposit for air ticket of \$3,000 per person will be required by 1 May 2014.

Flights may be ticketed once deposit payment is on file to avoid airfare surcharges or additional tax increases levied by the airlines.

Many airlines has strict upgrade policy; not all booking classes are upgradable to premium economy or business class. Please check with us when making reservation. You may need to pay extra for certain upgradable booking class.

3. Cancellations and cancellation fees This is a special charter group. Cancellations are very costly and usually do not occur in time for resale of the cancelled tour. All cancellation must be sent to CBT Holidays in writing.

The following per person cancellation fees apply.

Initial Deposit is non-refundable.

More than 360 days prior to departure: deposit 360-250 days prior to departure: 30% of total price 249-150 days prior to departure: 50% of total price 149-100 days prior to departure: 70% of total price 99-60 days prior to departure: 85% of total price within 60 days prior to departure: 100% of total price.

CBT Holidays reserves the right to cancel or reschedule any tours; the only responsibility of CBT Holidays will be to refund to the passenger the amount we have received for the tour reservation. All tour itineraries are subject to minor change upon local arrangement.

4. Insurance

There is no insurance coverage in our tour price; and no responsibility is accepted by CBT Holidays for

any loss of or damage to baggage or any of the tour participant's belongings. We strongly recommend that you take out comprehensive insurance cover against any cancellation, medical expenses, personal accident, lose or damage of personal baggage / belongings, money and public liability when you pay the deposit.

5. Amendment fees

A fee of \$50 per transaction may apply for any alteration or amendment made to a confirmed reservation. Airline penalties may also apply. A change to traveller name after air tickets have been issued will be treated as a cancellation and cancellation fees apply.

All prices are in Australian dollars based on twin share and subject to change without notice due to increases of airfares, hotel accommodation charges or currency exchange rate fluctuations. However, the tour prices are guaranteed for those who have paid their deposit or full payment, but except any Government / airport taxes and charges, airlines fuel surcharges increase.

9. Visas & Passports

A valid national passport is needed for all tours. Please make sure that your passport is valid for at least 6 months from date of travel, and at least there is two blank pages left in the passport for the visa label.
